Located at 51 boulevard Saint-Marcel, the hotel enjoys a strategic Left Bank position in an area that is undergoing rapid transformation, a stone's throw from the Gobelins, Latin Quarter, Jardin des plantes and the rue Mouffetard, one of the oldest streets in Paris, full of cafés, bistrots and food shops.

This new management strengthens the presence of Paris Inn Group in Paris on the 4 and 5 star segment.
